In your letter dated July 26, 2005, you requested the U.S. Nuclear Regulatory Commission (NRC) staff's endorsement of NEI 05-10, "Security Frequently Asked Questions (SFAQ) Process," as an acceptable means for the industry and NRC to resolve generic questions concerning the implementation of security requirements. The purpose of this letter is to provide our conditional endorsement of NEI 05-10 for industry use. Conditions of the staff's endorsement are noted in the Enclosure to this letter.

As you know, over the last nine months, the industry worked closely with the NRC staff to pilot the SFAQ process by conducting monthly meetings. Twenty-seven of thirty-five questions were resolved during this period; the remaining eight questions continue to be reviewed and discussed. In addition, the pilot provided the opportunity to make adjustments and enhancements to this process. Representatives from your staff and NRC staff have met periodically outside the monthly meetings to discuss and refine the SFAQ process presented in NEI 05-10. We look forward to receiving a "final" NEI 05-10 document that incorporates our conditions described in the Enclosure.
