Dear Freedom of Information and Privacy Act Officer:

Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, we submit this request for the following records:¹

1. Records related to the Homestake Mining Company site ("the Site") located in Cibola County, New Mexico (SUA-708, SUA-1471, Docket Number 04008903 or 408903). The records sought by this request include the following:

(a) Public records related to the Site to the extent that such records are not available through the Adams or Public Legacy databases.²

(b) All non-public records related to Site. So that NRC may release confidential documents, we are enclosing a letter of release from Gregory A. Lang, Vice President of Homestake, North America, granting NRC permission

to release records designated by Homestake or its predecessors as confidential business information, as protected trade secret or as otherwise not publicly available.

(c) U.S. Nuclear Regulatory Commission (NUREG - 1145)/AEC Annual Reports from 1956 to 1998, specifically the sections of the Annual Reports that discuss Homestake.

(d) All records related to sampling or analysis of groundwater required pursuant to Atomic Energy Commission (AEC) regulations or requirements, including requirements imposed under Radioactive Material Licenses for the Site.

(e) All records of inspections conducted by NRC of the Site pursuant to Radioactive Material License SUA-708.

(f) All records of inspections conducted by NRC of the Site pursuant to Radioactive Material License SUA-1471.

(g) All records related to violations, notices of violations, or deficiencies issued to Homestake Mining Company under Radioactive Material License SUA-708.

(h) All records related to violations, notices of violations, or deficiencies issued to Homestake Mining Company under Radioactive Material License SUA-1471.

(i) All records related to groundwater studies, investigations, or remediation conducted at the Site.

(j) All records related to the Corrective Action Plan for groundwater remediation submitted by Homestake Mining Company to the NRC in 1989 for incorporation into License SUA-1471.

(k) All records related to studies, investigations, or remediation of wind blown tailings in the vicinity of the Site. The records sought by this request include all records related to soil sampling and analysis.

(l) All records related to monitoring or sampling of air at, on, adjacent to or otherwise related to the Site.

(m) Records of complaints or inquiries about the by Site, from 1959 through the present, from persons living in the proximity of the by Site. By proximity, we mean the area within 10 miles of the by Site, including but not limited to Grants and Milan, New Mexico and the residential neighborhoods known as Felice Acres, Broadview Acres, Pleasant Valley Estates and Murray Acres.

(n) Records, from 1959 through 1990, related to occupational exposure and monitoring at the Site.

(o) Records, from 1959 through 1990, related to tailings sampling and disposal at the Site.

(p) Records, from 1959 through 1990, related to tailings ponds at the Site.

(q) Records relating to the 1977 breach of the tailings pond at the Site.

(r) Records, from 1959 through 1990, relating to the AEC/NRC licensing and license renewal of the Site.

(s) Records reflecting any other FOIA requests regarding the Site, including but not limited to FOIA requests from Rebecca Lorenz, Michael Alaird, Jr., or anyone associated with Melat, Pressman & Higbie LLP, the Spence Law Firm or the Alaird Law Firm.

We understand that there may be fees associated with responding to this request. Please let us know if you expect the fees to exceed \$500.00. As




