This letter forwards NRC Form 591, "Safety Inspection," indicating that no items of non-compliance were found during the above described inspection of your licensed activities. Please retain the form in your files. No acknowledgment of this letter is required. However, should you have any questions, we shall be pleased to discuss them with you.

During the inspection, questions were raised regarding the disposition of Troxler Gauges which you previously possessed. During a review of your license after returning to the Region, it was noted that your NRC License number 29-19517-02 for the Civil Engineering Department, previously authorized the possession of Troxler gauging devices. This license was terminated on December 23, 2002. We have also evaluated the annual review of the radiation protection program for 2004 which we received on July 18, 2005.
