2) Physical Description

This shipment consists of 48 x 48Y Cylinders loaded on 1 lash barge (48 cylinders per barge). RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted (HEELS). Total net weight of U – 227.577 kgs.

3) Transportation and Route Schedule

The ocean transportation and inland barge transport from Rotterdam, Netherlands to Paducah, KY will be the responsibility of Forest Line Inc. and Excell Marine Corporation. The surface transportation from Paducah, KY to Metropolis, IL will be the responsibility of RSB LOGISTIC SERVICES INC.
