Dear Sir or Madam,

Per the requirements of NUREG 1556, Volume 15, Appendix F, we are providing early notification of a proposed transfer of control of the NRC radioactive materials program identified below. Geisinger Health System Foundation has entered into an agreement with Catholic Healthcare Partners to purchase the assets and assume operation of Mercy Hospital Wilkes-Barre, under a newly formed corporation, Geisinger South Wilkes-Barre. The preliminary closing date as listed in the agreement is September 1, 2005, but will likely change based on the completion of several pre-closing requirements, including approvals from the Pennsylvania Attorney General and licensing by the Pennsylvania Department of Health. The options regarding the radioactive materials license are under consideration and once finalized, an amendment will be filed fully describing any changes in license status along with changes in personnel and the radiation safety program.





7. Records: The transferor has agreed to transfer or make available all records concerning facility decommissioning, surveys, and survey methods.
8. Transferee commitment: Transferee commits to abiding by all constraints, conditions, and requirements of the transferors licensed program, or will submit a complete description of the proposed licensed program for approval by NRC prior to initiating change.
