The Department of Environmental Protection/Bureau of Radiation Protection (The Department) has finished it's review of the Environmental Assessment Related to an Amendment of U.S. Nuclear Regulatory Commission Materials License No. SMA-1018, Issued to Whittaker, Corp dated August 8, 2005. The Department agrees with NRC's Finding of No Significant Impact (FONSI) in the Environmental Assessment. It is our understanding that this license amendment will allow for decommissioning activities to continue onsite despite their recent change in decommissioning approach. It is also clear that NRC will be reviewing Whittaker's change in approach when a revised Decommissioning Plan is submitted.
