A termination radiation and contamination survey of our 3125 Rivers Bend Blvd. office was performed on August 22, 2005, by our Nuclear Medicine Technologist Suzanne Journigan and reviewed by our consultant Medical Physicist, Dr. Dean Broga (see attached). The potential presence of removable radioactive contamination was assessed using the swipe test method. The swipes were analyzed for gross contamination using a CAPRAC (s/n 085) NaI well counter which has a 75% efficiency for ^{57}Co (the calculated MDA is 3×10^{-5} uCi). No significant gross contamination was identified.

Fixed contamination levels and exposure levels were assessed in using a Ludlum Model 3. The results are given on the attached diagram. No significant areas of fixed contamination could be found. No measurable levels of exposure over background were found.

We would like to release this facility for unrestricted use.

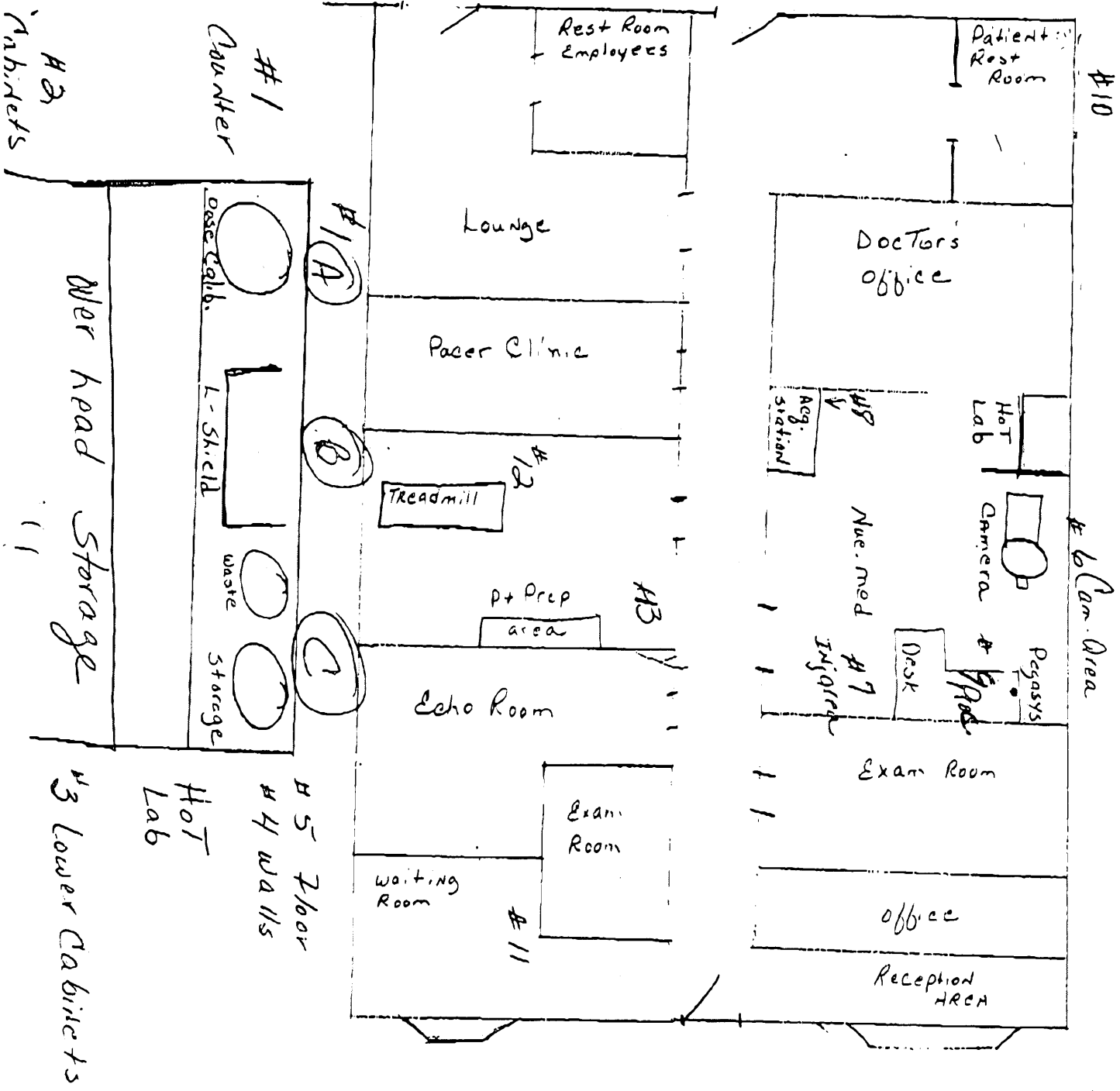
