MEMORANDUM AND ORDER

Before us is the NRC Staff's August 26, 2005 motion seeking clarification of the request for information made during the course of the August 24, 2005 telephone conference on the Army's motion to dismiss this materials license proceeding involving the decommissioning of the Jefferson Proving Ground (JPG) site. By way of clarification, we now advise the parties that our intent was simply to call upon the Staff and the Army, after consultation between them, to provide us with a brief joint report stating, in broad strokes and without disclosing any sensitive information, whether access to the JPG site is as or more restrictive than access would be to a nuclear power plant in the Safestor mode while awaiting decommissioning. That report will now

be due for filing and service no later than noon (EDT) on Friday, September 9, 2005 and shall not exceed three pages in length.
