Enclosed is Amendment No. 54 to your NRC Material License No. 13-01535-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that in accordance with my telephone conversation with Larry Miller, Radiology Manager, 3 iodine-125 sources could not be authorized at this time. They are as listed in your amendment request the following; BEGIG GmbH, IsoSeed I-125, Ibt, Intersource 125, Model 125IL and Nucletron, Selectseed I-125, Model 130.002. These sources as listed could not be found in the Sealed Source and Device Registry (SSDR). If further information is obtained concerning these sources that would help identify them in the SSDR, please provide that information in a future amendment request.


You will be periodically inspected by NRC.
