We have completed our review of your site-wide Integrated Safety Analysis (ISA) Summaries, submitted by letter dated October 15, 2004, associated with Materials License SNM-1227, and accepted by our letter dated March 30, 2005 (ML050890445).

Our technical review of the ISA Summaries, and our on-site review the week of June 26, 2005, have identified selected technical issues that require additional information. The additional information, specified in the enclosure, should be provided within 30 days of the date of this letter.

Pending additional information, which answers the Request For Additional Information questions, we anticipate completing our review by the end of January 2006. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
