Upon consideration of the August 22, 2005 motion of applicant Louisiana Energy Services, L.P., (LES) seeking continued designation of certain documents in this proceeding as “protected materials” withheld from public disclosure, and the August 29, 2005 response of intervenors Nuclear Information and Resource Service and Public Citizen (NIRS/PC) to that motion, it is

ORDERED, that on or before noon Eastern Time on Wednesday, September 7, 2005, LES and the NRC staff respond to the argument by NIRS/PC that document LES-PRO-00662 should not be protected because LES has filed no supporting affidavit, and thus has not carried its burden of proof relative to, the continued protection of that document. See Memorandum on Behalf of [NIRS/PC] in Response to Motion by [LES] to Maintain Designation of Certain Documents as Proprietary (Aug. 29, 2005) at 7.
