SUMMARY

Certificate of Compliance No. 6206, for the Model No. B package, has been revised to reflect the new 10 CFR Part 71 regulations (69 FR 3698) that became effective on October 1, 2004. Framatome ANP, Inc., did not request any changes to the package design or authorized contents.

EVALUATION

The following changes have been made to the certificate:

- Condition No. 5(c) was revised to delete the wording "Minimum criticality safety index to be shown on label for nuclear criticality control."
- Condition No. 12 was changed to reflect the new expiration date. In accordance with 10 CFR 71.19(a)(3), Type AF packages approved by the U.S. Nuclear Regulatory Commission (NRC) before September 6, 1983, are no longer authorized for use after October 1, 2008. Certificate of Compliance No. 6206, was initially approved by the NRC on January 31, 1975.

CONCLUSION

These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
