NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

Subject: ORDER PROHIBITING INVOLVEMENT IN NRC-LICENSED ACTIVITIES  
(IMMEDIATELY EFFECTIVE)

This is to inform the Commission that an Order Prohibiting Involvement in NRC-Licensed Activities will be issued on or about September 8, 2005, to Mr. John Myers. The Order is being issued based on information obtained during an OI investigation, which determined that Mr. Myers deliberately acquired and possessed byproduct material contained in portable gauging devices without a NRC or Agreement State license by providing false and inaccurate information to the licensee, ECS Mid-Atlantic, LLC (formerly Engineering Consulting Services, Inc.)

As the President and sole employee of Universal Calibrations, Mr. Myers sold and repaired portable gauging devices for ECS Mid-Atlantic, LLC and provided training for their employees. Mr. Myers received and possessed several of these devices, transporting them from the State of Virginia to the State of Maine, to service them. He did this knowing that an NRC or Agreement State license was required. Further, Mr. Myers purchased a portable gauging device from the ECS Mid-Atlantic, LLC's Richmond facility by providing false and inaccurate information representing to the licensee that he did have a license that authorized him to receive and possess NRC licensed material. The licensee terminated their relationship with Mr. Myers as a result of the investigation conducted by the Office of Investigation.

It should be noted that the individual has not been specifically informed of the enforcement action.

The States of Virginia and Maine will be notified.

The individual has 20 days from the date of the Order in which to request a hearing.
