Your U.S. Nuclear Regulatory Commission (NRC) quality assurance (QA) program approval expired on August 31, 2005. The requirements stated in 10 CFR Part 71 only require QA program approvals for licensees, Certificate of Compliance (CoC) holders and applicants for CoCs. Since FBF Nuclear Containers, LLC is not an NRC Licensee, CoC holder or applicant for a CoC, the NRC hereby terminates your NRC QA program approval under docket number 71-0185. Therefore, you are no longer authorized to design, test, repair, fabricate, procure, modify, assemble, maintain, or use radioactive material packagings in accordance with 10 CFR Part 71 under docket number 71-0185.

Although a small number of Part 71 QA program approvals were previously issued to fabricator entities, this practice has been discontinued. Fabrication activities for NRC-certified packagings must be performed in accordance with a CoC holder's QA program.
