

B. RADIOACTIVE MATERIAL SHIPPING PAPERS AS REQUIRED BY 49CFR 172.202 WERE FOUND TO INCLUDE INACCURATE U.N. IDENTIFICATION NUMBERS. THE CORRECT NUMBERS WERE INCLUDED ON PACKAGES. LICENSEE WILL CORRECT THIS DEFICIENCY WITHIN TWO WORKING DAYS.
