Purpose of Meeting: An open predecisional enforcement conference will be held to discuss the apparent violation identified during an NRC routine inspection conducted on June 22, 2005 - June 24, 2005 and concluded at the NRC regional office on July 28, 2005. If necessary, portions of the conference will be closed to the public to discuss sensitive security aspects of the apparent violation. The apparent violation involves the failure to control access or maintain surveillance of a high dose rate remote afterloader (HDR) which was left unsecured and unattended in the HDR treatment room on November 19, 2004.
