THIS IS TO NOTIFY YOU OFFCXXX OFFICIALLY OF THE OCCURENCE OF AN ACCIDENTAL NUCLEAR CRITICALITY INCIDENT AT UNITED NUCLEAR CORPORATION- S FUELS RECOVERY PLANT IN WOOD RIVER JUNCTION, RHODE ISLAND, 6-06 P.M. JULY 24, 1964. THE AEC WAS NOTIFIED VERBALLY A FEW MINUTES AFTER THE INCIDENT THROUGH NATHAN WOODRUFF OF THE WASHINGTON OFFICE.

THIS SUPPLEMENTS PREVIOUS WIRE REPORTING NUCLEAR INCIDENT 7/24/64 AT WOOD RIVER JUNCTION, RHODE ISLAND.

ACCIDENT OCCURRED WHEN MR. ROBERT PEABODY Poured AN ENRICHED URANIUM SOLUTION FROM A ELEVEN LITER SAFE GEOMETRY CYLINDER INTO A TWENTY GALLON CHEMICAL MAKEUP TANK ON THE THIRD FLOOR OF THE EXTRACTION COLUMN TOWER.

PEABODY REMOVED HIMSELF FROM THE PLANT TO THE EMERGENCY CONTROL BUILDING 200 YARDS FROM THE PLANT. SYMPTONS ON ARRIVAL AT THE EMERGENCY BUILDING WERE NAUSEA WITH VOMITING. PEABODY WAS TRANSFERRED TO RHODE ISLAND HOSPITAL IN PROVIDENCE BY WESTERLY AMBULANCE ACCOMPANIED BY ONE OPERATOR.

PLANT WAS OCCUPIED BY FIVE MEN AT TIME OF INCIDENT. ALL ASSEMBLED AT EMERGENCY BUILDING AND CHANGED CLOTHING. SUPERVISOR CLIFFORD SMITH SUMMONED AID BY TELEPHONE, ESTABLISHED ROAD BLOCK, AND ATTENDED PEABODY.

PLANT WAS RE-ENTERED OUT 7-45 P.MO BY SMITH AND PLANT SUPERINTENDENT  
R. A. HOLTHAUS, WHO HAD BEEN CALLED TO THE PLANT. THEY DRAINED THE  
TWENTY GALLON TANK INTO A THREE INCH COLUMN AND PARTIALLY INTO ONE GALLON  
CONTAINERS.

AREA AROUND PLANT WAS MONITORED FOR BETA GAMMA CTIVITY BUT SHOWED ONLY  
LOW VALUES. CONTAMINATED MATERIAL WAS BELIEVED TO BE CONTAINED BECAUSE  
OF LOW ACTIVITY LEVELS INDICATED ON PORTABLE BETA GAMMA DETECTORS, AND  
DETAILS OF PLANT CONSTRUCTION IN THE AREA OF THE ACCIDENT.

REMAINING PERSONNEL SHOWERED AND CHANGED CLOTHING AGAIN IN PLANT AT  
9-30 P. M. THEY WERE THEN SENT TO RHODE ISLAND HOSPITAL, EXAMINED AND  
RELEASED.

RADIATION MONITORING AND AIR SAMPLING WERE CONTINUED THROUGH THE NIGHT  
WITH NO APPARENT DANGER TO THE PUBLIC SHOWN.

INVESTIGATION OF INCIDENT HAS BEGUN. A FULL REPORT WILL BE SUBMITTED  
BY UNITED NUCLEAR CORPORATION

Dear Sir:

As a follow-up on our official communications to you notifying you of a nuclear criticality incident at United Nuclear Corporation's Fuels Recovery plant in Wood River Junction, Rhode Island; operations of a production nature at the plant have ceased.

Decontamination work is proceeding and the accumulation of data for incorporation into United Nuclear's report to the Atomic Energy Commission of the incident is taking place.

We will not begin operations of a production nature in this plant before a conference is held with you and your designees for purposes of presenting to you our findings, current plant status and our remaining courses of action.

When this information has been accumulated in presentable form, we will request such a conference with you.
