Dear Mr. Sharma:

Enclosed is Amendment No. 39 renewing your NRC Material License No. 21-04127-06 in accordance with your request.

Please note the following concerning your renewed NRC License:

- 1. Your license is formatted to correspond with NUREG 1556, Vol. 9, Rev. 1. and Vol. 5. The conditions that apply to your medical use program and non-medical use program were taken directly from the sample licenses found in the above NUREGs.
- License Conditions No. 22 and 23 were added since these topics did not appear to be addressed in your application for renewal. These conditions are in Appendix C of the above NUREGs.
- 3. License Condition No.14 of Amendment No. 38 was removed since the financial assurance quantity for cobalt-60 is 100,000 curies, a quantity not authorized by your NRC License.
- 4. License Condition No. 15 of Amendment No. 38 was removed since your application stated that you would comply with 10 CFR 35.630 and 35.632. 10 CFR 35.634 was removed since there is no 35.634 currently in the regulations.
- 5. Please note that depleted uranium (DU) was consolidated for the irradiator and teletherapy unit. However, please note that License Condition No. 17 of your renewed license requires that you maintain levels of DU below the quantities that would require you to submit your financial assurance program to the NRC.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
