SUBJECT: DEPARTMENT OF HEALTH AND HUMAN SERVICES, REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION FOR RENEWAL OF LICENSE, CONTROL NO. 137213

Dear Mr. Strong:

This is in reference to your application dated June 10, 2005 requesting to renew Nuclear Regulatory Commission License No. 19-07538-05. In order to continue our review, we need the following additional information:

- 1. In your renewal application you request to add Sulfur-35 to your license but did not address the use of Sulfur-35 in many of your procedures. Please confirm that all activities applicable to Hydrogen-3 and Carbon-14 will also apply to Sulfur-35.
- 2. Please confirm that you would like to remove Jerry Collins as an authorized user from the license
- 3. In section 10.a of your renewal application, it states that the RSO will approve or decommission specific areas where radioactive materials are used and stored. Please specify your criteria for approval and decommissioning. Also note that pursuant to 10 CFR 30.35(g), licensees are required to maintain records important to decommissioning.
- 4. Please provide a description of the radiation monitoring instruments (e.g., gamma counter, solid state detector, portable or stationary count rate meter, portable or stationary dose rate or exposure rate meter, single or multi-channel analyzer, liquid scintillation counter, proportional counter, etc.) that will be used to perform radiation level detection, measurement, and contamination surveys. Appendix M of NUREG-1556 vol. 7, "Consolidated Guidance about Materials Licenses: Program Specific Guidance About Academic, Research and Development, and Other Licenses of Limited Scope" will help to formulate your response.

- 5. Pursuant to 10 CFR 20.1501, licensees are required to make surveys of potential radiological hazards in the workplace. Please verify that you will survey and maintain contamination levels in accordance with the survey frequencies and contamination levels published in Appendix Q to NUREG-1556 Vol. 7. Section 8.10.7 of the same guidance will help to formulate your response.
- Please confirm that sewage disposal meets the criteria set forth in Section 8.11 of NUREG -1556 Vol. 7, "Consolidated Guidance about Materials Licenses: Program Specific Guidance About Academic, Research and Development, and Other Licenses of Limited Scope". Refer to Appendix T of that guidance document to help you in formulating your response.
