Dear Mr. Sisley:

By letter dated June 30, 2005, BNG Fuel Solutions Corporation (BFS) submitted, in accordance with the requirements of 10 Code of Federal Regulations 72.244, an application to the U.S. Nuclear Regulatory Commission (NRC) to amend Certificate of Compliance (CoC) No. 1007. BFS is requesting changes to the Technical Specification requirements related to monitoring during storage operations.

This is to inform you that the application appears to contain the necessary information to begin our technical review. The schedule below establishes the key milestones and dates associated with the application through completion of our review. Please note that the schedule allows for the staff to issue a possible request for additional information (RAI) in November 2005. If no RAI is needed, and based on the staff's evaluation, our Safety Evaluation Report and CoC amendment may be issued at approximately that time.

BFS Responds to RAI	December 1, 2005
NRC Issues License Amendment	March 1, 2006

In general, no additional changes to the application will be allowed except for those minor changes that result in responding to an RAI. Additional changes, supplements, or enhancements may be treated as a new application.
