


Dear Mr. Kirslis:

This to request exemption from the 10CFR70.51(f) requirement to remeasure UO₂ product lots which cannot be loaded into shipping containers prior to starting our July 7, 1987 physical inventory. This exemption is requested due to the difficulty and expense that would be involved in applying and then removing a tamper-safe paper seal for each of the stainless steel containers. As we discussed, the location, nature and packaging of the items make any change in contents unlikely.

In lieu of remeasurement of the recently produced UO₂ product lots, we will:

1. Reweigh 10% of the approximately 700 cans, selected at random.
2. Use gross weight agreement criteria equal to the greater of 0.5% of the gross weight or 100 grams.
3. Reweigh 100% of the cans if one or more exceed the agreement criteria. Inventory data and lot totals will be corrected for can differences exceeding 100 grams.

Please advise if you have a question. We appreciate your consideration and assistance.


We are requesting a delay in performing the 1986 review and audit to the week of May 11, 1987. The reason for the request is due to availability of review and audit team due to scheduling problems.
