The purpose of this unilateral modification is to provide incremental funding in the amount of \$10,469.00, thereby increasing the total amount of funds obligated from \$158,000.00 to \$168,469.00, and fully funding this task order. Accordingly, the following changes are hereby made:  
\*Task Order No. 005 shall be in effect from June 14, 2005 through December 15, 2005, with a cost ceiling of \$168,469.00. The amount of \$156,051.00 represents the estimated reimbursable costs, and the amount of \$12,415.00 represents the fixed fee. Funds in the amount of \$10,469.00 are being obligated by this modification. Total funds obligated under this task order are \$168,469.00. This task order is fully funded.\*
