
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to incrementally fund Task Order No. 003 under the subject contract in the amount of \$222,762.00, thereby increasing the obligated amount of this Order from \$150,000.00 to \$372,762.00.

Accordingly, the first sentence of paragraph (b) under Section **A.1 CONSIDERATION AND OBLIGATION** of Task Order No. 003 is modified to read as follows:
"A.1 CONSIDERATION AND OBLIGATION
...(b) The amount presently obligated with respect to this task order is \$372,762.00..."

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED, INCLUDING THE CEILING AMOUNT OF \$985,000.00.

This modification obligates FY2005 funds in the amount of \$222,762.00.
