To summarize the series of events mentioned in my phone message to you, in short, no one at the Bank could find the Standby Trust Agreement. PNC stated that they sold it to Mellon Bank, who in turn sold it to JPMorganChase, who claimed that they didn't have it and therefore wouldn't honor it. PNC called back late yesterday stating that they still had it and would hold onto it. The trustee information can be found on the attached document. Coincidentally, since PNC believed that someone else possessed the STA, they never charged us the \$2500 annual fee but will now going forward.

It is amazing how such a simple request can cascade into a near crisis.
