The licensee expressed that it would like to have the approval of the AST for FHA and LOCA in time for the CNS fall 2006 outage. The NRC staff discussed numerous operating experiences and concerns that occurred in reviewing AST submittals.

In addition, the licensee discussed its plan to submit a combined measurement uncertainty recapture (MUR) power uprate application with a stretch power uprate (SPU) application. The NRC staff noted that combining the MUR with the SPU application might cause unnecessary complications in establishing work responsibilities, use of review guidelines, and tracking various metrics and goals.
