Please clarify whether operations will be conducted at temporary job sites (i.e., locations where work is conducted for limited periods of time and from which gauge users are NOT dispatched to job sites for other customers). If so, please specify "temporary job sites anywhere in the U.S. where the NRC maintains jurisdiction".
2. Item 6 of your renewal application states, in part, that the gauges will be used in compatible Boart Longyear Company (formerly Campbell Pacific Nuclear Company) portable gauging devices.

Please specify the model number of the CPN International, Inc. (Formerly Boart Longyear Company and formerly Campbell Pacific Nuclear Company) portable gauging devices you propose to use.

3. Please provide either of the following:

Statement that: "Before obtaining licensed materials, the proposed RSO will have successfully completed one of the training courses described in Criteria in the section entitled 'Individual(s) Responsible for Radiation Safety Program and Their Training and Experience - Radiation Safety Officer' in NUREG-1556, Vol. 1, Rev. 1, 'Consolidated Guidance about Materials Licenses: Program-Specific Guidance about Portable Gauge Licenses,' dated November 2001";

OR

Alternative information demonstrating that the proposed RSO is qualified by training and experience.

4. Please expand Items 8 and 10 Operating and Emergency Procedures of your renewal application to include "Rev. 1, dated November 2001.
5. Please note that although you responded to Items 9, 10 Radiation Safety Program - Audit, 10 Radiation Safety Program - Termination of Activities, 10 Radiation Safety Program - Public Dose, 10 Radiation Safety Program - Transportation, and 11, you were *not* required to submit a response during the licensing renewal process.
