Enclosed is Amendment No. 37 renewing your NRC Material License No. 21-24380-01 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Your facilities located at 35300 Nankin, Suite 602, Westland, Michigan and 26139 Gibraltar Road, Flat Rock, Michigan were not included in your renewal application. Please be advised that we cannot release these facilities until you provide closeout surveys. These facilities will remain on your license until you provide closeout surveys in an amendment request. Also please note that the 17330 Northland Park Court, Southfield Michigan facility was added to your license. This was done concurrently with the termination of Northway Medical Center's NRC license.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
