Rules and Directives Bran Nuclear Regulatory Commission:

I am writing to OPPOSE Entergy's application for an Early Site Permit (ESP) at the Grand Gulf nuclear plant in Claiborne County, Mississippi.

The draft Envir. Impact Statement (DEIR) doesn't make it clear that the extra electric energy is needed.

The DEIR irresponsibly dismisses getting energy instead from renewable sources & conservation.

The plant will be 1 mile from the Mississippi & there is insufficient discussion of security for the plant & the river. Since the attacks in London security should be even more of a concern. There are many minorities & poor people in the area & they can't afford to pick up the tab for security.

New nuclear plants are very unwise seeing that we can't even find a good place for the nuclear waste that has already been generated. From things I have read in the past, Yucca Mountain will not be big enough to hold all the nuclear waste already generated by the 100 nuclear plants that already exist. There are also earthquake faults at Yucca Mt. I read that the data about Yucca Mt. storage was improperly prepared.

I feel that you need to seriously take nuclear waste disposal and security considerations into consideration before issuing permits for nuclear plants.

I hope you will take my ideas into consideration and decide not to build the Grand Gulf Nuclear plant.
