On May 5, 2005, the U.S. Nuclear Regulatory Commission (NRC) issued Orders (EA-05-086 and EA-05-087) to Public Service Enterprise Group Incorporated Nuclear (PSEG Nuclear) requiring implementation of interim safeguards and security compensatory measures (ICM) and additional security measures (ASM) associated with access authorization, respectively, for its dry storage independent spent fuel storage installation at the Hope Creek and Salem Generating Stations. On May 24, 2005, PSEG Nuclear submitted its written response to the ICM and ASM Orders.
