Dear Dr. McLaughlin:

As requested in the meeting held September 8, 2005, and in furtherance of the information provided in my letter to you of May 25, 2005, it is the intention of the Department of the Army to seek and secure all funding necessary to complete the actions contemplated in its current application for an alternative schedule to support the restricted decommissioning of the Jefferson Proving Ground (License SUB-1435).

The statement contained in my May 25, 2005 letter that the contemplated actions were subject to funding is to be understood as a reminder that the provisions of the Anti-Deficiency Act (31 USC §1341 et seq.) are applicable. The Anti-Deficiency Act prohibits a federal officer or employee from entering into a contract or agreement which obligates the United States Government to pay funds not yet appropriated. The actions contemplated under the current application extend over some five years. Congressional appropriations for the latter years have not yet been made. For this reason, my May 25, 2005 letter contained the caveat language.

While such language is necessary to comply with statute, it should not be construed as an indication that the Army will not use its best efforts to secure the necessary appropriated funds.
