[] STATED "THAT I'M IN ENOUGH TROUBLE AT WORK" AND "IF I GAVE YOU MY NAME IT WILL ONLY CAUSE MORE (TROUBLE)." [] ALSO STATED THAT BY ASKING FOR [] NAME "YOU'LL ONLY CAUSE ME MORE TROUBLE AND YOU'RE NO HELP." THE EMPLOYEE TERMINATED THE TELEPHONE CALL AT THAT POINT.
