This letter confirms the agreement between Mr. Michael Gaffney and me to have a regulatory conference at 1:00 p.m. (CDT) on Tuesday, November 8, 2005, at the NRC Region III Office, 2443 Warrenville Road, Suite 210, Lisle, IL 60532-4351. Following the regulatory conference, Kewaunee performance improvement initiatives will be discussed.

The purpose of the regulatory conference is to discuss the preliminary Greater than Green finding for safety related equipment susceptibility to internal flooding at Kewaunee Power Station, as documented in Inspection Report No. 50-305/05-11(DRP). Following the regulatory conference, discussions will be held concerning the March 18, 2005 Kewaunee performance improvement initiative letter and the September 15, 2005 letter endorsing commitments listed in the March 18 letter. The public is invited to observe this meeting and will have an opportunity to speak with the NRC after the business portion of the meeting, but before the meeting is adjourned.
