Pursuant to the provisions of 10 CFR §50.54(p), Florida Power Corporation, now doing business as Progress Energy Florida, Inc. (PEF), hereby submits, on CD-ROM, the Crystal River Unit 3 (CR-3) Physical Security Plan (PSP), Revision 4 and resubmits the CR-3 Training and Qualification Plan (TQP), Revision 0. The attached enclosure replaces the referenced letter, for the CR-3 TQP Plan, Revision 0, and the current CR-3 PSP, Revision 3, in their entirety.

The CD-ROM that contained the CR-3 TQP, Revision 0, was submitted to the NRC by the referenced letter, and was packaged and handled as containing Safeguards Information. Due to an administrative oversight, the text "Safeguards Information" was omitted from the header and footer of the CR-3 TQP, Revision 0. This oversight has been rectified and the addition of the "Safeguards Information" text to the CR-3 TQP, Revision 0, header and footer are the only changes that have been made to the CR-3 TQP, Revision 0. Therefore, the changes made to the CR-3 PSP, Revision 4 and the CR-3 TQP, Revision 0, do not decrease the effectiveness of the Plans.
