FISCAL YEAR (FY) 2006 MASTER INSPECTION PLAN

Dear Mr. Sepp:

In accordance with NRC Manual Chapter 2602, "Decommissioning Oversight and Inspection Program for Fuel Cycle Facilities and Materials Licensees," NRC Region III staff and management have developed a Master Inspection Plan (MIP) for the Hematite facility. The plan is based on your current performance and proposed schedule of decommissioning activities for the site from October 2005 through September 2006 (FY2006). The plan outlines how we intend to focus our Regional inspection resources to address significant ongoing decommissioning activities.

Because the FY2006 MIP is based, in part, on your proposed schedule of significant decommissioning activities for FY2006, the plan and the focus of NRC inspection activities may change to reflect a change in your planned decommissioning activities or your performance. In order to ensure that the FY2006 MIP remains current, we request that you keep the Decommissioning Branch staff informed of any significant changes in your proposed schedule of decommissioning activities. You will be informed of any significant changes to the Hematite FY2006 MIP.

We currently project that the Region will conduct 4 inspections during FY2006. The inspection procedures, which we may use during our inspections, are listed below. The use of specific procedures will depend on the decommissioning activities being conducted.
