- Entergy and the IBEW Local 300 the Union have tentatively agreed to terms on a new three-year contract at Vermont Yankee. Results of an afternoon ratification vote are expected by 7:00 this evening. The current contract expires tonight at midnight. The contract applies to about 30% of Entergy employees on-site and involves individuals in operations, maintenance, radiation protection, chemistry, and document services. The NRC Region I Director of the Division of Reactor Safety is currently on-site, and the Region continues with the implementation of its strike preparation; including repositioning of additional staffing for around-the-clock inspector coverage.
