Request to Rescheduled the Problem Identification and Resolution Inspection for Monticello Nuclear Generating Plant (MNGP)

Reference: 1) USNRC to Nuclear Management Company, LLC "Mid-Cycle Performance Review and Inspection Plan – Monticello Nuclear Generating Plant," dated August 30, 2005

In Reference 1, the Nuclear Management Company, LLC (NMC) was provided the date for the Monticello Nuclear Generating Plant (MNGP) Problem Identification and Resolution (PI&R) Inspection. The PI&R inspection is currently scheduled to occur between July 10-28, 2006. Based on a review of the schedule for MNGP, NMC is hereby requesting that the inspection be rescheduled.

This request is based on the potential impact on station resources required to support the NRC inspection activity. Currently the NRC will be conducting another major inspection (Safety System Design and Performance Capability/system modifications) approximately three weeks prior to the scheduled PI&R inspection. Additionally, the last PI&R inspection was conducted at MNGP in February 2005 and therefore a July 2006 inspection would be less than the NRC biennial inspection requirement. Therefore, NMC is requesting to have the PI&R inspection be rescheduled after September 30, 2006.






