Commitment Responses Associated with an Application for Order

Consenting to Transfer of Licenses and Approving Conforming License Amendments

(TAC No. MC7225)

On May 18, 2005, the FirstEnergy Nuclear Operating Company ("FENOC") acting as agent for and on behalf of FirstEnergy Nuclear Generation Corp. ("FENGenCo") and Pennsylvania Power Company ("Penn Power"), submitted an application to the Nuclear Regulatory Commission ("NRC"). The submittal letter (Beaver Valley L-05-080 and Perry PY-CEI/NRR-2880L) requested an order consenting to the transfer of Penn Power's ownership interest in the Beaver Valley Power Station, Units No. 1 and 2 ("BVPS 1 and 2") and the ownership interest in Perry Nuclear Power Plant, Unit No. 1 ("Perry") to FENGenCo.

On June 1, 2005, FENOC acting as agent for and on behalf of FENGenCo, Ohio Edison Company ("Ohio Edison"), OES Nuclear, Inc. ("OES Nuclear"), The Cleveland Electric Illuminating Company ("Cleveland Electric"), and The Toledo Edison Company ("Toledo Edison"), submitted an application to the NRC requesting consent to the transfer of ownership interests involving BVPS 1 and 2, Perry, and Davis-Besse Nuclear Power Station, Unit No. 1 ("Davis-Besse"). The submittal letter (Beaver Valley L-05-0100, Davis-Besse Serial Number 3156, and Perry PY-CEI/NRR-2886L) requested an order consenting to the transfers of specific Ohio Edison, OES Nuclear, Toledo Edison, and Cleveland Electric ownership percentages of BVPS 1 and 2, Perry, and Davis-Besse to FENGenCo.

A listing of Regulatory Commitments was contained in each submittal. This letter fulfills three of the commitments.

First, a commitment was made in both the May 18 and June 1 submittals to provide a listing of the FENGenCo principal Directors and Officers, and their business addresses.

Attachment 1 provides the listing. The individuals named are U. S. citizens.

Second, a commitment was made in both the May 18 and June 1 submittals to provide a form of the Power Supply Agreement (PSA) between FENGenCo and FirstEnergy Solutions. Based upon a telephone conference held on September 14, 2005 between the NRC and FENOC staffs, the FENOC staff understands that having the PSA available for inspection

is considered satisfactory by the NRC. A form of the PSA is available to the NRC for inspection or submittal based upon the needs of the NRC. The PSA will be executed when the generation assets are transferred to FENGenCo.

Third, based upon the order of submittal approval, FENOC committed to supplying revised conforming Operating License page markups to support the NRC licensing actions. The commitment is contained in the June 1 submittal. Based upon a telephone conference held on September 12, 2005 between the NRC and FENOC staffs, the FENOC staff understands that the NRC will address both submittals in a single order. Since the conforming Operating License page markups that were submitted as part of the June 1, 2005 submittal reflected the changes associated with both requests, revised page markups will not be required.
