
- 1. **AUTHORITY:** 5 U.S.C. 552a(b)(12) (2000); 5 U.S.C. 5514 (2000); 15 U.S.C. 1681a(f) (1993); 26 U.S.C. 6103(m)(2) (1999); 31 U.S.C. 37, subchapters I and II; 31 U.S.C. 3701(a)(3) (1996); 31 U.S.C. 3711, 3716, 3717, 3718, 3720A (2000); 42 U.S.C. 2201 (1996); 42 U.S.C. 5841 (1994); Cash Management Improvement Act Amendments of 1992 (Pub. L. 102-589); 10 CFR Parts 15, 16, 170, and 171 (2000); Executive Order 9397 dated November 22, 1943; Debt Collection Improvement Act of 1996 (Public Law 104-134).
- 2. **PRINCIPLE PURPOSE(S):** To obtain taxpayer identification number / social security number / individual taxpayer identification number to enable the NRC to collect delinquent debts.
