SUBJECT: PITTSBURGH CANCER CENTER, L.L.C., REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION FOR AMENDMENT TO LICENSE, CONTROL NO. 137690

Dear Mr. Gosai:

This is in reference to your letter dated September 19, 2005, requesting to terminate Nuclear Regulatory Commission License No. 37-30753-01. In order to continue our review, we need the following additional information:

1. A review of your license and inspection records indicates that you possess(ed) a Cesium-137 dose calibrator reference source and possibly possess(ed) a Cesium-137 patient attenuation device in an ADAC Model C-PET 250 device. Please provide, for our review, a copy of the most recent leak test record(s) for the sealed source(s) and a letter from the recipient of the sealed source(s) indicating that the sealed source(s) has/have been received. If the sealed source(s) has/have not been transferred to an authorized recipient and remain in your possession, then the license must remain in force and can not be terminated.
2. On October 7, 2005, it was determined that the licensee still owed annual fees pertaining to licensed operations. If you have not already paid these fees, please contact William Blaney at 301-415-5092 and determine the amount of fees that is currently owed. Termination of this license can not proceed until all debts are paid.
