
Pursuant to the H. Res. 437, 109th Cong. (2005) establishing the House Select Bipartisan Committee on the Preparation for and Response to Hurricane Katrina, and Rules X and XI of the House of Representatives, we ask that you produce all documents requested by the October 7, 2005 letter from the Senate Committee on Homeland Security and Government Affairs ("Senate Committee") seeking information and the production of documents related to the preparation for and response to Hurricane Katrina.


