Attached is the second revision to the Advanced Notification of Export Shipment (DLN:03:083) for the movement of SNM to Korea that I sent to you by fax and by mail on 9/23/03. The shipment of SNM will be departing Oakland, CA for Korea on October 9th and will be sailing on the "Hanjin Beijing". The material is going under export license XSNM03273.

There now will be 72 ANF-250 shipping containers as compared to the earlier declaration of 70 containers. The total kilograms of Uranium decreased from 4,478 kgu's to 4,476 kgu's. A copy of this letter will be mailed to you today.

2. Physical Description

Seventy two (72) ANF-250 shipping containers of which Seventy two (72) contain enriched UO₂ and none (0) are empty. The shipment contains 4,476 kgU and 116 Kg²³⁵U at an average enrichment of approximately 2.60 wt% U²³⁵. The ANF-250's are loaded in three sea containers.

3. Transport Route

The shipment will depart from Oakland, CA via the vessel "Hanjin Beijing" going to Busan, Korea. Upon arrival at Korea, KEPCO Nuclear Fuel Company, or its agent, will take physical custody of the shipment as arranged prior to shipment.

4. Schedule

The shipment is scheduled to depart Richland on October 6, 2003 and to depart Oakland, CA on October 9, 2003 and is expected to arrive at Busan on October 21, 2003.

5. Assurance

The shipment will be protected during transport in accordance with IAEA Information Circular 225, "Physical Protection of Nuclear Materials".
