Good Afternoon George,

We completed our review of the revised Implementation Plan for the Energy Policy ACT dated October 5, 2005, and found that the plan addressed the areas that we discussed during our meeting on October 4, 2005 on this topic. We focused our review of this revision of the plan on the revised resource estimates, lead and support designation as well as the projected dates included in the plan. This revised plan addressed all areas that we discussed with you on October 4, 2005, and our supplemental meeting on October 6, 2005, resolved our final concern about the estimated resources to support the security rulemaking area of the Energy Policy Act, therefore we do not have any additional comments that need to be incorporated into the final plan.

During our meeting on October 4, 2005, we briefly discussed the resource estimates and changes that you are recommending with the biggest change for NRR is an additional 1 FTE allocated to support Section 638 entitled "Standby Support for Certain Nuclear Plant Delays." The remaining budget estimates are consistent with the estimate prepared in response to a question raised by Commissioner Jacko regarding the potential budget impact of the Energy Bill earlier this year which was estimated prior of the approval of the Energy Bill.
