**Subject:** Re: Louisiana Energy services

We are responding to your recent communication dated September 20, 2005, in which you raised the two issues discussed below:

(1) Adequacy of Decommissioning and Decontamination Funding

LES is responsible for paying for the cleanup of its proposed NEF. LES is currently proposing to operate only in New Mexico, but would be responsible for remediation of any contamination resulting from operation of its facility regardless of the State in which the contamination is located. The LES estimate for decommissioning includes decontamination of buildings and equipment and costs for dispositioning all the depleted uranium generated during the 30-year lifetime of the plant. LES is proposing to use a surety bond, one of the acceptable mechanisms for assuring the availability of decommissioning funds, to meet the NRC decommissioning financial assurance requirements. The surety bond can be used if LES goes into bankruptcy.

(2) Radioactive Waste Disposal

Under the settlement agreement with the State of New Mexico, LES has made certain commitments regarding the disposal of depleted uranium which are independent of the NRC's licensing requirements and, as such, are not subject to oversight by the NRC.
