**PROGRAM SCOPE**

The licensee is a radiographer located in Rochester, Michigan with authorization to use material at temporary job sites where the NRC maintains jurisdiction. This licensee has six full time radiographers and is in possession of two 880 exposure devices.

**Performance Observations**

At the time of the inspection, licensee was not performing radiography using a gamma source. Therefore no temporary job site was observed. The inspector reviewed the paperwork associated with the use of the radiographic devices and interviewed personnel that performed radiography. All personnel appeared to possess an adequate level of knowledge of radiation protection.

Independent surveys around the storage facility yielded minimal results. Although licensee personnel are badged, readings for the past year were low and did not exceed 500 mRem on average.

No violations of requirements were noted.
