Dear Mr. Sepp:

We have received your request for amendment of Materials License SNM-00033 dated October 6, 2005. We have completed the initial processing, which is an administrative review of your request for approval of changes to Sections 4.3.1 and 7.3.1 of the Hematite Fundamental Nuclear Material Control Plan (FNMCP), Revision 7. An administrative deficiency was identified during this initial review. You did not sign the document. We are processing your request but ask that you submit a signed copy to the docket. We will review and determine the adequacy of all proposed revisions to the FNMCP for the Hematite Facility, to include your May 31, 2005, request to make organization changes in Section 3.3, Revision 6. However, it should be noted that a technical review may identify omissions in the submitted information.

It appears that your request is routine. Routine amendment actions are normally processed within 90 days, unless we find major deficiencies, or policy issues requiring central program office assistance.

In addition, a copy of your submittal has been forwarded to License Fee and Accounts Receivable Branch, Office of the Chief Financial Officer. They will contact you separately if the appropriate license fee has not been submitted for your request, or for billing if your request is subject to full cost recovery.

Your request has been assigned Technical Assignment Control (TAC) No. L52647. Any future correspondence about this request should reference the TAC number.

We will try to complete your requests for approval of changes to the license to allow receipt of radioactively contaminated waste material produced as a result of waste processing of Hematite general scrap material at an offsite facility in a timely manner.
