14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to: (1) exercise Optional Tasks 2 through 7, and (2) incorporate, by reference, the Contractor's May 2, 2005, Mitigation Plan. Accordingly, the contract is modified as follows:

"The NRC hereby orders Optional Tasks 2 through 7. As a result, Section B.3, Consideration and Obligation-Firm Fixed Price (June 1988) is deleted entirely and replaced with the following:  
The firm fixed price of this contract is \$200,972.00 for performance of Tasks 1 through 7. The total amount of funds obligated at this time is \$200,972.00. (\$14,675.00 at contract award and \$186,297.00 under this modification. This contract is fully funded. The Contractor's May 2, 2005, Mitigation Plan is hereby incorporated by reference."

All other terms and conditions remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
