We have completed our acceptance review of the renewal application, and have identified no administrative omissions or deficiencies. The renewal application has been accepted for formal review. Please note that the complete technical review may identify omissions in the submittal information or technical issues which require additional information. Because you filed the application for renewal not less than 30 days before the expiration date stated in your existing license, your existing license will not expire until the Commission makes a final determination on the renewal application, in accordance with the timely renewal provision of 10 CFR 70.38(a)(1).

Based on our acceptance review and projection of current review schedules, we anticipate completing the technical review by August 2006. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.

In addition, a copy of your submittal has been forwarded to the License Fee and Accounts Receivable Branch, Office of the Chief Financial Officer, who will contact you separately for billing, as your request is subject to full cost fee recovery.
