1. On 24-28 January 2005, the Naval Sea Systems Command Detachment, Radiological Affairs Support Office (NAVSEADET RASO) conducted the subject inspection of radioactive commodities operations authorized by Naval Radioactive Materials Permit (NRMP) No. 10-67004-T1NP. Reference (a), a formal report of the inspection was issued by the Chairman of the Naval Radiation Safety Committee (Chief of Naval Operations (N455)). Reference (a) assigned an unsatisfactory rating, required four immediate corrective actions, and required a formal command response to 13 cited findings within 30 days of the date of the letter with progress responses required every 30 days until all findings were adequately corrected. Reference (b) provided a detailed review of the progress report provided by reference (c) and specified the additional actions required to closeout the inspection.

2. Reference (d) provided the latest 30-day progress report to address the immediate actions and cited inspection findings of reference (a). All proposed corrective actions stated in reference (d) are considered acceptable for closeout of the inspection when implemented. We also agree to eliminate cited finding F.74 due to the change in leak test requirement per reference (e). There are two immediate actions and 10 cited

findings still open and requiring progress reports. A current list of items remaining open and requiring progress reports are as follows:

(b) Findings A.7, B.9, E.7, E.9, F.56, I.1, I.2, I.3, I.4 and I.5.

3. The reference (a) requirement to provide continuing 30-day progress reports for all pending immediate actions and inspection findings remains in effect.
