All our correspondence has been in terms of MWt (1593 to 1912) since the thermal level is what is in the license. When you talk in terms of MWe, the numbers are sometimes expressed in gross or net. The current net rating is 510 MWe per the NRC Info Digest. 20% on top of that would be about 100 Mwe increase.
