Temporary Job Site South Side Landfill Project, Indianapolis, IN

PROGRAM SCOPE

The licensee was a small private engineering/consulting firm employing 6 engineers at its Greenwood field office. The licensee possessed 5 moisture/density gauge used daily for road construction projects during the construction season. The licensee approved six individuals (all successfully completed the manufacturer's training course or other approved training course) as authorized gauge users. The licensee retained the services of a consulting firm for program audits, training and gauge maintenance/repair services.

During this inspection, the inspector toured the gauge storage area, surveyed the gauge storage bin, interviewed select licensee personnel, and reviewed select records. The inspection included a field inspection of one gauge user at a temporary job site. At the time of the field inspection, the gauge was not in use. The inspector interviewed the gauge user and observed his use of personnel dosimetry, and surveillance/use/security of the gauge. The inspector also reviewed the shipping papers and performed surveys around the gauge transport container and the passenger compartment of the transport vehicle.
